**Author's Note:** This is an index to a volume of Final Oaths which were filed in Hendricks County court during the years 1856 through 1906. A Final Oath was the second and final step in the naturalization process. Final Oaths did not have to be filed in the same court as the Declaration of Intent, and usually did not contain as much information as the Declaration.
