

MADAME MARIE FERREE

Madame Ferree is generally regarded as the ancestress of all the Ferrees in America. The name has been spelled in various ways: Fierre, Fier, Free, Firro, Fuehre, Fiere, etc. Since about 1750, nearly all the members of the family have written their surname as we do now. An outline of the life of Madame Ferree follows.

She is generally thought to have been born Anna Marie Warenbur, (also spelled several ways - Warrenbur, Warimbere,) about 1650-1653. She married Daniel Ferree, who was a silk weaver. Daniel is said to have been a descendant of Jean La Verra, of whom we know nothing more. They became Huguenots or French Protestants. The family lived first in Picardy and later in Flanders. When the Edict of Nantes was revoked in 1685, and took away liberty of worship from the Protestants, the family of Daniel Ferree fled to Landau in the German Palatinate. Later they removed to Steinweiler, and adjacent village. Daniel Ferree died before 1708, but neither the place nor the year of his death is now known.

After the death of her husband, Madame Ferree is said to have resumed her maiden name of Marie Warenbur, according to a French custom at that time. She and her family decided to emigrate to America. With this in view, they obtained a certificate of church membership from the French Reformed (Walloon) Church at Pelican, dated May 10, 1708. Previously, on March 10, 1708, they obtained a civil passport from the Court Clerk of the Mayoralty of Billigheim in which the town of Steinweiler was located. This passport stated that the "purpose to emigrate from Steinweiler, via Holland and England to the Island of Pennsylvania". Copies of both documents can be found in Rupp's History of Lancaster County. The church certificate is in French, the civil passport in German.

Whether Madame Ferree or any of her children remained for any length of time in Holland is not now clear. It is almost certain that some of the family could not have tarried long in that country, for on August 28, 1708, Isaac LeFevre (married to Madame Ferree's daughter, Catharine) and Daniel Ferree (one of Madam Ferree's sons) and some others secured for themselves and their families, Letters of Denization for the British Colonies. It is certain that Daniel Ferree and Isaac LeFevre, with their families, accompanied the Revered Joshua de Kachenthal in the ship "Globe" and that they arrived at New York on January 1, 1709.

down in one sum, 'tis agreed that they shall pay only ten Pounds interest, that is 150 Pounds in the whole". Thus the two thousand acres were patented, not to Maria Warenbur, but to her son, Daniel and her son-in-law, Isaac LeFevre.

Legally, Madame Ferree never owned a foot of land in Pennsylvania, although the land has always since been known as the Mary Ferree tract. Nevertheless, on November 7, 1712, Mary Ferree paid a year's quit rent on the tract and received a receipt for it in her own name.

Evidently the land was intended for the family as a whole, and was to be divided among the various members of the family. Later, Daniel Ferree and Isaac LeFevre made out deeds in their own names and in favor of various members of the family, each grantee paying his proportional share of the original purchase price. These deeds are recorded in Lancaster County.

In dividing and resurveying the land it was discovered that, instead of containing two thousand acres of land, the Mary Ferree tract really contained two thousand, three hundred acres. This was taken up with the proper authorities, and it was agreed that the Ferrees might keep all of it provided they paid the additional twenty-one Pounds for the additional three hundred acres. This was paid, and accordingly, on October 29, 1734 "John Penn, Thomas Penn, and Richard Penn, Esqrs., true and absolute Proprietaries and Governors in Chief of the Province of Pennsylvania and the Counties of New Castle, Kent, and Sussex on the Delaware" gave the Ferrees a new patent in place of the old one which they surrendered. In the meantime and later, the individual members of the family took up more land, so that in all, they received probably five thousand acres by patent.

Madame Ferree died about January, 1716. Letters of Administration on her estate were granted to Daniel Ferree, Philip Ferree, and John Ferree, her sons, by the Register of Wills of Chester County, of which Lancaster County was then a part. The bond of the administrators, set at two hundred Pounds, was signed by Isaac LeFevre and Richard Davis, two of Madam Ferree's sons-in-law. This bond is dated November 28, 1716. An appraisal of the personal estate of Mary Ferree was made; this inventory was filed May 22, 1717.

Madame Ferree (con't)

Mary Ferree was buried in what later became the Ferree Graveyard and is also known as Carpenter's Graveyard. This cemetery, later legally set aside as a cemetery, is located about one mile south of the town of Paradise, in Lancaster County. Madame Ferree is said to have been the first to be interred there. Although no one can be sure of the exact spot, someone has lately put up a small marker in the farthest corner of the cemetery, and has cut on it the initials "M.F." and the year "1716". The cemetery plot was originally one hundred and eight feet long and ninety-six feet wide. It was legally set aside as a cemetery in 1787, and document for it is recorded in Lancaster County.

The following material is taken from the files of the late Thad S. Ferree, Sr. of Raleigh, North Carolina.

Jacob Ferree (b. ca. 1850, probably in Rowan Co., NC- died between 13 August 1807 when his will was made, and 17 August 1807 when proved, Allegheny Co., PA. He was not born in France. His father, Isaac Ferree (b. ca. 1725-died 1759 in NC) was a son of Philip and Leah (DuBois) Ferree, and married Elizabeth Forbush (Forbis), daughter of George and Olive Forbush.

Philip Ferree came to America ca. 1709. So did his mother, Madam Maria Warembourg Ferree (Fiere) and brothers, Daniel and John, and sisters Catherine, Maria, and Jane.

Jacob Ferree married his first cousin, Rachel Ferree, daughter of his uncle, Joel Ferree (see below) and (1) Mary Copeland. He did not marry in France. They were married 8 August 1770 at St. James Church, Lancaster Co., PA, "by Licence", performed by Rev. Thomas Barton. They had children: Joel Leah, Rebecca, Jane and Elizabeth. Rachel (Ferree) Ferree died in 1782; buried at Ferree-Carpenter Cemetery, near Paradise, PA.

Jacob Ferree married (2) Alice Powell of Chester Co., PA., on 1st July 1785 at Lancaster Co., PA, Trinity Lutheran Church by Rev. Henry Muhlenberg. The certificate is still in existence. They had nine children: Rachel, Isaac, Olive, Mary, Anna, Lydia, Jacob M., William Powell and Lavinia.

Joel Ferree (Feb. 1731-June 1801). Joel was not a brother of of Jacob Ferree (see above). He was his uncle, also a son of Philip and Leah (DuBois) Ferree, and Jacob's father-in-law as well.

Joel Ferree married four times but only had three children, all three by first wife, Mary Copeland. As stated his daughter, Rachel, married her first cousin, Jacob Ferree, son of Joel's brother, Isaac.

Records state that Joel was buried at the Ferree-Carpenter Cemetery near Paradise, Pa. His will is at the Lancaster Co., Courthouse, Pa.

If the information contained in Allegheny County, PA Revolutionary War Soldiers (1988) is from NSDAR records it is incorrect, and NSDAR should be contacted.
