



Claus Stolley Apr. 3rd 1858.



**Injuries Suffered In Fall At
 Home Oct. 6 Led To
 His Death**

James W. Brandenburg, one of Arcola's oldest and esteemed residents, passed away last Friday morning in Jarman Hospital, Tuscola, his death being due to injuries and shock which he received in a fall at his home on October 16. He suffered a fractured hip and other injuries and though it was thought for a while that he would recover, returning to his home here for a couple of weeks but later being taken back to the hospital, the shock proved too great and he died last Friday morning.

Funeral services, in charge of the Walton Funeral Home, were held at the Arcola Christian Church at 2:00 o'clock Monday afternoon with the Rev. H. L. Hayes, pastor, officiating. Interment was in the Arcola cemetery.

He had been a resident of this community for nearly three-quarters of a century. He was born in Fayette county, Missouri, on May 2, 1858, and his father died when he was only 12 years of age. That was in 1870 and he moved to Mattoon with his mother, Mrs. Clara Brandenburg. They lived there a short time and then moved to Charleston. In 1873, they moved to this community, from Charleston, and he continued to live here until the time of his death.

He was married to Anna Barricklow, daughter of the late Mr. and Mrs. Mathias Baricklow, on Dec. 2, 1882. She preceded him in death, having died on April 22, 1884. Later he was married to Miss Cora Stolley and they celebrated their golden wedding anniversary some time back. They made their home on a farm southwest of Arcola until he retired and they moved to town.

He was well known throughout this section and highly respected by all. He was quiet but possessed a cheerful disposition and was always ready to lend a helping hand. He never knowingly offended any one.

He is survived by his wife, who in recent years has not been in the best of health; two sons, Glades of Arcola and Dale of Marseilles; five grandchildren and a host of friends and relatives.
