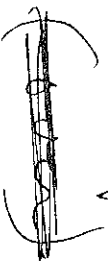

The home plantation was Borden's Great Spring
Tract of 3143 acres, granted Oct. 3, 1734, joined
Greenway Court, on the SE. Also had 1122, on Bullskin
marsh, near Summit Point, now W. Va., & a large tract
on Smith's Creek, near New Market, Shenandoah Valley Co.

On Nov. 6, 1739 he secured patent for 92,100 acres
on headwaters of James River. - Borden's Manor. in
present Rockbridge Co., Va. - Friend of Lord Fairfax
Fairfax purchased from the son John Borden in 1756
608 acres of the Great Spring Tracts.

Benj. Borden was born in 1692, a son of Benj.
and ~~---~~ (Gover) Borden, near Freehold N. J.
& died in Frederick Co., Va. in 1743. He married
Zeruiah Winter of West New Jersey, & came to Va. 1732.

Benjamin Borden, Sr., was prominent in
Orange¹⁷³⁴ Co., & then Frederick Co., - 1743
- Religious persecution Orange Co., Va. Oct & Nov. 1737.

His will dated April 3 1742 and probated
October 9, 1743 in Frederick Co. Va., mentions
wife Zeruiah; sons; Benjamin, Jr., John, and
Joseph; daughters; Abigail, wife Jacob Worthington
Hannah - Captain Edward Rogers.
